1. I AGREE/PERMIT MY CHILD/CHILDREN TO PARTICIPATE IN THE LANSDALE SWIM & DIVE TEAM.
2. I RECOGNIZE THAT SOME OF THE ACTIVITIES IN THIS PROGRAM COULD BE DANGEROUS AND RESULT IN SERIOUS INJURY OR DEATH.
3. I WILL EXPLAIN TO MY CHILD ALL OF THE RULES AND SAFETY PROCEDURES ASSOCIATED WITH THE SWIMMING POOL AND PARTICIPATING ON THE LANSDALE SWIM & DIVE TEAM. I UNDERSTAND THAT IF MY CHILD FAILS TO COMPLY WITH THE RULES AND SAFETY PROCEDURES ASSOCIATED WITH THE TEAM MY CHILD WILL BE DISMISSED FROM THE TEAM WITH NO REFUND.
